FLEIS & VANDENBRINK: Ken Mlcek reviewed financial analysis of the water fund provided by Tom Traciak, Baker & Tilly. The analysis included:

- Comparative Statement of Net Position

- Comparative Detail of Operating Expenses with Test Year

Based on fiscal data, a rate adjustment of quarterly RTS \$57.75 and \$4.40/1,000 gallon of water usage with 2% increases annually thereafter is recommended by Baker & Tilly to support USDA Water Improvement Project.

French moves, supported by Heyn, to approve the recommendation of Baker & Tilly by increasing the RTS fee from \$52.00 to \$57.75 and cost/1,000 gallon of water usage from \$4.00 to \$4.40, with a proportional increase to larger line RTS fees effective 1st quarter of 2020.
