- Bill Kennis Mr. Kennis presented the 2021 Annual Report for the Benzie Bus. Kennis discussed the Federal grant that they were awarded to start a new, personalized health and wellness service, they have also created a reserve fund to handle future building, grounds and vehicle needs, this along with additional funding from the CARES act has put them in great shape financially. They are continuing efforts in obtaining a federal electric bus grant to fund four electric vehicles to add to the fleet.
- New Plow Truck A discussion took place regarding the purchase of a new plow truck. The village is in need of buying a new plow truck the total cost

is \$201,764.00. Grand Traverse Diesel services the 18 counties north of the Grand Rapids area, and the Council was informed by the freight liner dealership in Grand Rapids that they will not quote us a price as the difference would between what Grand Traverse Diesel and themselves would not be significant. Being that they are the only two dealers in Michigan, the council is seeking auditor recommendations regarding this purchase through a single supplier. The council agreed to tentatively approve the purchase of the plow truck contingent upon auditor recommendations. Cook moves, supported by French to approve the tentative purchase of a new plow truck for \$201,764.00 from Grand Traverse Diesel, contingent upon auditor recommendations.
