Kathleen Hibbard – Informed the council that she attended the planning meeting, and reported that the Planned Unit Development on Homestead & Marshall has not yet been decided upon.

Discussion regarding letter from Thomas Rohrer took place, Mr. Rohrer would like for the Village to improve Killdale road, Mr. Rohrer reiterated a portion of his letter where he believes that the Village is responsible to improve the road as he believes that the entire road has been accepted. President Flynn read the portion of the minutes which explains that the acceptance of Killdale in the 1998 minutes pertained to using the Right of

Way on Killdale to the South of River St for the purpose of extending a water main South. Which limited the improvement to the quick claim deeds that were part of the motion to extend the water main. Hafer suggests to add culverts to his property at Mr. Rohrer expense. (Mirror what the neighboring property has done).

President Flynn discusses the costs to improve the road and that it is not feasible for the Village to do. Perhaps the Village could allow a Right of Way so that a drive way could be installed at the owner's expense.
