STEVE STEPHANS, VILLAGE BAUTIFICATION UPDATE:

- Shares that work is beginning on the Benzonia Museum gardens, a 'garden of remembrance' has been found on the hillside, asks where the Village boundaries are. A U-shaped wooden walkaway is being considered. Permission is given to remove invasive autumn olive plants.
- Mills Community House revisiting fence extension. People continue to walk through the gardens, Stephans has erected temporary fencing.
- Striping of parking lot Village responsible for handicap striping; requesting village hold off as the Mills Community House will be having the parking lot sealed. Proposes Mills Community House will stripe the parking lot if the Village will repair the fencing.

Ornamental stone walkway at Post Office is being taken over with weeds, needs
to be tended to. Superintendent and Assistant Superintendent will address the
issue.
