\*\* For Zoning Amendment, Appeals, and Requests for any Public Hearings – Fees include the publication of legal notices and postage to mail notices to adjacent property owners, preparation time, copy costs, mileage and reproductions. Any costs incurred in excess of these above fees will be billed to the applicant. Expenses will be documented and report provided on request. Applicant shall be required to pay additional fees related to professional fees and out of pocket expense to include but not limited to engineering, survey, planning or legal fees if needed to provide additional review of submitted plans and application to determine the extent of conformance or non-conformance to the adopted Village Ordinances, Master Plan or any other ordinances or statutes related to the Village of Benzonia that may affect the outcome of the ruling.
